During the second quarter of 2012, my efforts have been focused on executing the reorganization of SIG-Health that began with revision of our bylaws in March and in setting up SIG-Health events at AMCIS 2012 (Americas Conference on Information Systems), being held this year in Seattle, WA. Here is a month-by-month recap of those activities.

May –"Health-IS Professional Development" was set to be the theme of our pre-AMCIS workshop for 2012. In order to guide the workshop agenda, we sent an email survey to SIG-Health members asking them about interests in teaching and research areas. Responses indicate that members have strong interests in both teaching and research, so we set out to address both aspects in the workshop.

June – A nominating committee chaired by Immediate Past President Rich Klein recruited candidates for President-Elect, Secretary, and Treasurer elected SIG-Health offices. These are new positions brought about by revising SIG-Health Bylaws in March to conform with new AIS standards. After elections are completed, we will have a full executive board comprising President-Elect, President, Immediate Past President, Secretary, and Treasurer. Each position is a two-year term, however, the initial Secretary will be elected for three years in order to alternate election years for Secretary and Treasurer positions.

July – Panel discussants, roundtable directors, and speakers for the pre-AMCIS workshop were confirmed, and you can view a full agenda in a separate article in this newsletter. Elections were opened with Gondy Leroy of Claremont Graduate University nominated for President-Elect, Gary Hackbarth of Northern Kentucky University for Secretary, and Ann Fruhling of the University of Nebraska-Omaha for Treasurer.

Looking forward to AMCIS 2012 – All successful conferences require lots of work, and I want to thank all the SIG-Health members who volunteered their time to organize AMCIS events. Along with our pre-AMCIS workshop, eight paper minitracks and a poster session are being sponsored by SIG-Health. In addition, you are invited at 4:00 PM Thursday (August 9) to come to a panel moderated by Priscilla Arling in which Rich Klein, Gordon Gao, and I will take a shot at "Reflecting on the Role of IT and IT Research in Healthcare: Moving Healthcare Research into Practice."

SIG-Health Business Meeting – AMCIS is where we hold our annual business meeting, which is scheduled to run from 6:00 to 7:00 PM on Friday (August 10) in the Aspen Room on the second floor of the Seattle Sheraton. I hope to see you there!



The AMCIS 2012 schedule is online, again this year, as an available link from the AIS website (http://amcis2012.abstractcentral.com/planner). The scheduling tool allows AMCIS attendees to browse online the preconference activities, 14 panel sessions, 6 workshops, 15 ancillary meetings, 24 tracks, 484 paper abstracts, and 86 poster presentations—prior to your arrival. Moreover, individuals who cannot attend are able to see conference activities and share in the knowledge dissemination.

The scheduling tool allows conference attendees to map and plan their itinerary, day-by-day, with schedule conflicts highlighted. AMCIS attendees can browse and search conference activities by day or type, creating their own individualized conference itinerary that can be saved or shared with colleagues. 

Today's healthcare organizations face challenges of unprecedented complexity, breadth and intensity. Only a fraction of new scientific discoveries enter day-to-day clinical practice. To aid in the implementation of research into practice, healthcare organizations frequently turn to technology. However, even with the aid of technology, research often fails to be fully integrated into patient treatment. Part of the reason is due to the complexity of the healthcare system, which includes patients, providers, management, and local community input, all of which are influenced by the current political and economic environment. In addition, some authors have noted that studies have often lacked a rigorous scientific approach that would aid in predicting success in future implementations. Panelists will consider how the foundation theories and research in IT, as well as information technology itself, can be used to inform and facilitate the implementation of healthcare research into practice.
